Small Bore Rifle

Course of Fire: A/51 Targets: Shoot 3x10 course of fire at 50 yards. 10 shots each in prone (1 min per record shot), standing (2 min per record shot), and kneeling (1.5 min per record shot). Targets will be changed after each position. Qualifying score: 175 points out of a possible 300.

Muzzle Loader

Course of Fire: TG2406 target: Shoot 10 shots at 50 yards
TG2427 bottle target: Shoot 10 shots at 25 yards
Qualifying score: 75 points out of 200.

Small Bore Pistol

Slow fire B16 target,10 minutes for 10 shots Timed fire B8 target, 20 seconds per string of 5, 2 strings of 5 Rapid fire B8 target, 10 seconds per string of 5, 2 strings of 5

Shoot 30 shots (10 shots each Slow fire, Timed fire, and Rapid fire) at 25 yards (or 50 feet if 25 yards is not possible) at a state match committee approved event. (see Course of Fire above). Qualifying score: 125 points out of a possible 300.

Our host site, Mill Creek Rifle Club, has asked that every non club member who comes to the match sign the attached standard waiver form. As invited guests of the club, we feel we should follow their request. Note this form is needed for everyone who comes to the match: Participants, coaches, and spectators. If your shooter is under 18, parents should sign the form on their behalf. Signed forms must be returned before they participate in the match. (You can bring them with you the day of the match.)

I, ("Undersigned") do hereby affirm and acknowledge that the use	of
firearms involves inherent hazards and risks. I fully understand that these risks include injury an	nd
death. I freely accept and expressly assume all risks and hazards that may arise from the use	of
firearms by myself and others while on the premises of The Mill Creek Rifle Club, Inc.	
In consideration of participating in or observing firearm activities on the The Mill Creek Rif	le
Club, Inc. (hereinafter MCRC) premises as a guest, I agree to the following:	

- 1. To release, discharge and hold harmless MCRC and all members, officers, directors, trustees, representatives, agents and employees (collectively "Releasees") from any and all fault, loss, liability, cost, expense, claims, demands and causes of action that I, my estate, heirs, executors or assignees may have for any loss, personal injury, illness, property damage or wrongful death that may arise from participating in or observing firearm activities on MCRC premises.
- 2. By executing this agreement, the Undersigned expressly waives any and all rights and claims for damages, losses, demands and any cause of action that may arise against Releasees, either as a result of actions by the Undersigned, the Releasees, other guests or any other party. Such waivers include but are not limited to any and all claims for injuries, damages or illnesses which may arise out of the use of firearms on the premises, or from the condition of the premises. This agreement applies to both the Undersigned and to any minor for whom it is executed. The agreement binds the Undersigned and his/her executors, administrators, assignees and/or heirs, and those of any minor for whom it is executed.
- 3. The Undersigned hereby expressly acknowledges that Releasees are not liable for any physical injury, death or property damage incurred by the Undersigned while on MCRC premises, even if such physical injury, death or property damage is caused by Releasees' negligence. The Undersigned expressly acknowledges and assumes the risk of taking part in the full range of firearm activities including the discharge of firearms, observing individuals discharging firearms and/or any other use or condition of the premises.
- 4. The undersigned acknowledges that her/his presence on the MCRC premises is entirely voluntary. The Undersigned hereby expressly acknowledges that he/she is an invited guest of a member of a private club and that access and use of the premises is a conditional privilege that can be revoked for unsafe or inappropriate conduct, or terminated at any time for any reason by the member, and/or a club officer, Board Member or designated club official. If told or requested to leave the premises, he/she agrees to leave immediately. Further, the undersigned acknowledges and agrees that his/her participation in activities on the MCRC premises will be conducted in a safe manner and in compliance with all MCRC Range Rules. Copies of the MCRC Range Rules are located in the clubhouse and posted adjacent to the front door on the outside of the clubhouse.
- 5. This agreement shall be governed by and interpreted in accordance with the laws of the State of Kansas.

By signing below, the Undersigned hereby declares that he/she is 18 years of age or older and competent to sign this agreement and, if executing the agreement on behalf of a minor (under the age of 18 years), the Undersigned is the parent or legal guardian of the minor for whom it is executed. By signing this agreement, I understand that I waive certain legal rights, including the right to sue.
