Sedgwick County Shooting Sports coaches, shooters & parents will be hosting a State Qualification Match for small bore rifle and small bore pistol for 4-H members ages 13-18. All shooters must be enrolled and have completed instruction in a Certified Kansas 4-H Shooting Sports program for the disciplines in which they enter. State qualifying rules will be observed in each of the disciplines. Check the State 4-H Shooting Sports website for all qualifying rules.

We will be using the center and west ranges for our match.

Entry forms are due by 5:00 p.m. on Tuesday, July 23, 2024. Late registration only accepted to fill relays. *Fees will be \$10.00 per shooter, per discipline.* There will be no awards. Fees will be collected at onsite registration. Email form and questions to susieklausmeyer@gmail.com.

This will be a 4-H Kansas State Qualifier for Small Bore Pistol and Small Bore Rifle The minimum age to PARTICIPATE at the State Match is 12.

**Small Bore Pistol:** Shooters will shoot the following course of fire: 25 yard range distance: Slow fire – B16 target; 10 minutes for 10 shots Timed fire – B8 target, 20 seconds per string of 5, 2 strings of 5 Rapid fire – B8 target, 10 seconds per string of 5, 2 strings of 5. **To qualify for the State Match, the minimum individual score is 125 out of 300 possible**.

Small Bore Rifle: Shooters will shoot the following course of fire: A/51 Targets: Shoot 3x10 course of fire at 50 yards to include 10 shots each in prone (1 min per record shot), standing (2 min per record shot), and kneeling (1.5 min per record shot). Targets will be changed after each position. To qualify for the State Match, the minimum individual score is 175 out of 300 possible.

There will be no concession stand. Please make arrangements to bring your own food and water.
