The River Valley District 4-H Trap Team is hosting a state trap qualifying event on Saturday, August 9. This event will be held at the Cloud Co. Fairgrounds, 615 Industrial Rd. east of Concordia, KS. Registration and Practice Rounds will begin at 8 a.m. The Shoot will begin at 9:00 a.m.

### **Age Requirement:**

4-H Age 10-13 before January 1 of current year = Juniors/Intermediate

4-H Age 14-18 before January 1 of current year = Seniors

Event Fee will be \$25.00 per youth for 50 shots. Practice is offered for \$10.00 per round. Youth must be 4-H age 10 through 18 before 1/1/25 to participate.

50 clays will be shot from the 16-yard line. **A qualifying score must be 35 hits out of 50.** Current ATA and 2021 Kansas State Match Rules apply. The first 50 course of fire will be counted towards the qualifying score. No skeet will be offered at this event.

All shooters will need to bring and be responsible for their own shotgun and shells. Ammunition must be new shells only, no reloads, no larger than 12 ga, with a maximum shot size of 7 ½ lead shot and a maximum shot charge of 1 ⅛ oz. Eye and ear protection is required for anyone past the ready line. No barrels are to be resting on toes, feet, or aimed at any other part of the body. A shell catcher is highly recommended on semi-automatic shotguns. Youth are required to pick up and dispose of all empty shell cartridges at the end of their 50 shots.

Individual Awards will be given in each age division along with a team award.

During the Qualifier, attendees will have access to an air-conditioned facility for comfort and relaxation. A concession stand will also be available, providing a selection of food and beverages.
